Abstract:

Dalits/Untouchables still lives outside the village and not allowed to enter in the temples because of their lower hierarchy. These untouchables are there even in the beautiful Himalayan mountains. There are all over Asia where there is Hindu religion *Dalits* are there in the lower hierarchy order. The Justice delayed is justice denied in the age old situation of *Dalits*. Where is UN in all these years and yet it goes to give awards to the man who made law against *Dalits* to uplift the Holy Cows and crush down *Dalits*. Where are international organizations that are playing commercial adds in our main stream media (Do you know how much an add costs when it plays in the prime time and other times?), millions and taxes for that so you can imagine how much fundraising is done in the name of global poverty. Who own them big business owners and political leaders and Church leaders. Where did all the money of generous hearts go for centuries? Very little reached to *Dalits* to recognize them as human beings in educating them through Christian missionaries and other advocacy nonprofit organizations around the world. CNN covered the situation of *Dalits* even before I was born and it might have gone unnoticed or it does not get money to make America great!? UK is the eye witness because they colonized my country and have seen *Dalits* suffer. Some time BBC talks about *Dalits* and that is consolation. These are the random thoughts of my abstract for 15th Annual HumanDHS Workshop on Transforming Humiliation and Violent Conflict.

I would like to explain about what is caste system in India and subhuman treatment until now. They are about 16 per cent of the Indian population and number about 138 million. I would like to play two recent cases related to love between dalit boys and upper caste girls. Provisions in the Constitution for *Dalits* and those provisions will not reach to them. The Hindu religion placed

Dalits in the low position in the social structure. Hence, very few *Dalits* represent in the government, trade, commerce and industry service adequately. They are continuously suffering from social and physical isolation from the rest of the community. Qualitative education does not reach to them and even if they get educated they do not get jobs because of their socio religious low status - Constitutional Safeguards and reservation policy. Most of them are day laborers and paid 2 dollars a day. They buy groceries with that 2 dollars for that day and next day they have to work again to get that two dollars. If there is no work then they borrow some groceries from their neighbors and if the neighbors do not have the work then they go hungry. So how can they think of educating themselves and their kids? They are alienated from the village if they have any conflict with the higher castes of the village. As a result they are not allowed to buy the groceries from their village nor able to get any work from the landlords of that village. Poverty that leads to sickness and sickness that leads them to the death. When the natural disaster comes the huts of the *Dalits* are wiped out and they are the most affected by natural disasters.
